Terminology: Seychelles National Diaspora Policy (2024 - 2029) defines the Seychellois diaspora as "Emigrants from the Republic of Seychelles who were born in the country and their descendants, regardless of the respective citizenship of the descendants, who retain an affinity to the Republic of Seychelles and remain interested in participating actively in the sustainable economic and social development of the society of the Republic of Seychelles, at home and abroad.

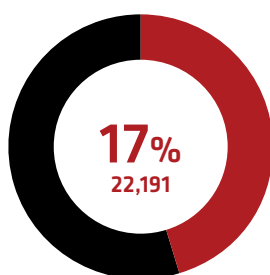

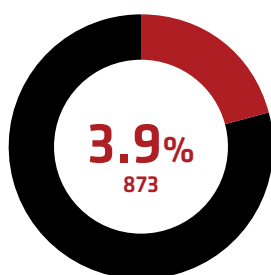
% of emigrants in

Overview of the policy and legislative framework



- 2019** ● Vision 2033³ refers to the need to recruit diaspora and expatriate skilled professionals, although no special provisions have been made for the former, or to promote circular migration. This may change after Seychellois citizens lose the right to visa-free travel to Europe in 2022.
- 2019** ● National Labour Migration Policy⁴ sets out objectives in relation to developing an efficient labour market (3.1) and ‘managing and upskilling the labour force’ (3.4), including through diaspora skills transfer.⁵ It includes the following objectives relevant to diaspora engagement:
- To consider mobilizing technical and intellectual diasporas to engage in public sector development projects, or to provide technical assistance;
 - To provide a clear mandate to embassies and consular representatives abroad for engaging in diaspora relations.
- 2024** ● **Seychelles National AfCFTA Implementation Strategy⁶** is a strategic framework to guide Seychelles in leveraging benefits and opportunities opened up through the African Continental Free Trade Agreement (AfCFTA). Aligning with the NDS 2024 - 2028, this framework proposes to leverage the Seychellois diaspora communities in other African nations to enhance the visibility of the Seychelles brand, attracting capital, knowledge, and technology.
- 2024** ● **Seychelles National Development Strategy (NDS)⁷** further recognises diaspora investment as part of essential funding for priority development projects outlined in the NDS.
- 2024** ● **Seychelles National Diaspora Policy and its National Diaspora Action Plan⁸** In collaboration with the International Organisation for Migration (IOM) and with financial support from the EU-funded Southern Africa Migration Management (SAMM) project, the Seychelles Government launched its first National Diaspora Policy covering the period 2024 - 2029. This policy aims to design and sustain an inclusive system of diaspora engagement that ensures the active participation of the diaspora in the sustainable economic and social development of the Seychellois society, at home and abroad. It is structured around three main pillars:
- 1. Governance of Diaspora Engagement:** establishing an inter-institutional mechanism to guide the policy planning and implementation process, with the diaspora in an observatory role, and strengthening the capacity of the Ministry of Foreign Affairs and Tourism (MFAT) to ensure effective implementation.
 - 2. Diaspora Diplomacy: Local & Global:** strengthening the communication and connections between the Government, local communities, and the diaspora; strengthening protection of the rights of the diaspora; and promoting the diaspora’s role in cultural diplomacy.
 - 3. Diaspora Capital for Development:** providing a hybrid portfolio of products, programmes, and partnerships to mobilise human and economic capital of the diaspora for national development in priority sectors.

The National Diaspora Action Plan 2024 - 2029 outlines granular planning for the core policy pillars and includes monitoring and evaluation outcomes as a stand-alone pillar.

Seychelles Indian Diaspora day 2018

On 9 January 2018 the government celebrated Seychelles Indian Diaspora Day, honouring Indian diaspora business leaders based in the country as well as the contributions of the Seychellois of Indian origin worldwide to the Seychelles.

Diaspora eRegistration campaign

The Department of Foreign Affairs (DFA) has introduced an eRegister system which is a voluntary and free service to all Seychellois citizens who reside overseas. The data will be used to update DFA data of Seychellois Diasporas living in other communities outside Seychelles. Registration has attracted over one thousand contributions with responses showing a distinct interest in receiving information on areas to invest in. Fisheries and tourism were sectors that were particularly popular according to responses. Data showed that the majority of respondents were located in Europe, mainly in France, Belgium and the UK.



Observations

The “Observations” and “Obstacles” sections contain additional information on the context of diaspora engagement that does not fit directly into the other sections. They are based on a combination of literature review and comments from the authors. New information is incorporated during the annual updates. Readers are invited to verify the relevance of the information at the time of reading, as the context may have evolved.

Often refracted through the lens of the politics of the Cold War, relations between Seychelles and its diaspora were strained until 1991, when a multi-party government returned to the Seychelles, due in part to the political activity of diaspora in exile. Under a joint exile return programme started in 1986/7, the Seychelles International Repatriation Onward Programme, most of the exiled political factions’ leaders returned to the country.⁹

There have been recurrent calls to allow diaspora voting rights. The Seychelles diaspora are very active politically, and have been known to fly to the country to participate in elections. In 2019, President Danny Faure promised that a bill for a referendum on allowing the Seychellois diaspora to take part in elections will be “tabled at the appropriate time”, although this was later withdrawn after criticism.¹⁰

Emigration of skilled professionals from Seychelles has been a challenge for the country since the 1970s, with educated Seychellois seeking employment opportunities abroad, particularly in Europe, due to better employment opportunities.¹¹ This has led to skills shortages that the government has sought to address through recruitment of skilled expatriate and diaspora professionals. While there have been some attempts to engage diaspora expertise in certain

sectors such as education, public health, and treatment of substance abuse, this has been the result of individual initiatives rather than as part of formal programmes.¹²

As an island nation, Seychelles is particularly vulnerable to rising sea levels linked to climate change, a fact recognised by the country's Vision 2033 strategy. The strategy makes reference to the potential for climate-change induced emigration from the Seychelles by 2033, including a worst-case scenario of an 'exodus'. While Vision 2033 does not set out actions in this regard, Seychelles is working with other island states and their allies for greater advocacy and action to address climate change, and there may be scope to frame diaspora engagement policies and practices in relation to mitigating the effects of climate change.¹³

With the creation of a new Diaspora Unit under the Department of Foreign Affairs in 2021, the government is giving greater importance to the role and contribution of the diaspora in the country's socioeconomic development. The Government of Seychelles created the Diaspora Unit to give Seychellois nationals living abroad a means to participate in the socioeconomic development of the island nation. This creation was followed by a registration initiative to strengthen the connection between the government and the diaspora. As of January 2022, a total of 1,182 Seychellois emigrants had registered with the diaspora unit.¹⁴

Obstacles



- **Fragmented diaspora:** The Seychelles diaspora, although large relative to the total population, is small and spread across multiple countries and regions. There are very few Seychelles diaspora groups in Europe and North America.
- **Lack of fiscal incentives:** Remittances flows to Seychelles are relatively modest, and the Seychelles diaspora is seen as lacking sufficient investment potential for policymakers to prioritise diaspora engagement policies and programmes.
- **Lack of trust:** A common diaspora perception of the government is that its policies have favoured expatriate investors and residents over the Seychellois. This has led to distrust of government policy towards the diaspora.¹⁵ Conversely, one legacy of the political exiles in the 1980s is an ambivalence on the part of the government towards its diaspora in Europe, Australia, and Canada that remained until relatively recently. This has arguably slowed the development of diaspora engagement policy frameworks in the country.

Diaspora related institutions

- **At regional level**

African Union Citizens and Diaspora Directorate (AU CIDO)

Seychelles is a member of the African Union and nominates a diaspora focal point to represent Seychelles as part of the African Union Citizens and Diaspora Directorate (AU CIDO) Continental Meetings.

Southern African Development Community (SADC)

Seychelles is a member of the SADC which is an inter-governmental organization headquartered in Gaborone, Botswana. Its goal is to further socio-economic cooperation and integration as well as political and security cooperation among 16 southern African countries

Common Market for Eastern and Southern Africa (COMESA)

The Common Market for Eastern and Southern Africa is a free trade area with twenty-one member states, including Seychelles.

Department of Foreign Affairs

The Department for Foreign Affairs is responsible for relations with the Seychelles diaspora.

Ministry of Employment, Immigration and Civil Status

The Ministry of Finance, Trade and Economic Planning is the lead agency for diaspora investment and trade

Diaspora unit 2021

The Foreign Affairs Department established its first ever Diaspora Unit in 2021. The Diaspora Unit is responsible to engage and interact with Seychelles' nationals living abroad by facilitating their queries and providing them with necessary guidance, in connecting further with their homeland. The Unit recognizes the important role the Seychelles nationals living overseas can play in the socio-economic development of the country.
