

# Overview of the policy and legislative framework



Government of Saint Lucia Diaspora Policy. From as early as 1996 consultative discussions about the role of diaspora engagement began. This eventually resulted in the Government of Saint Lucia Diaspora Policy being ratified in 2015. The policy sets out the Government of Saint Lucia's (GoSLU) trajectory for harnessing the capabilities of citizens resident abroad for home country development. It states that "engagement with the Diaspora must be constantly re-evaluated so that the type of engagement policy can shift as the country evolves." It seeks to focus on economic growth, poverty reduction, good governance, capacity building, and policy development that will redound to the benefit of all. The policy makes provision for the targeting and inclusion of diaspora for home country development by outlining focus areas aligned with the government's socio-economic plans. Though it is focused on Saint Lucians working together for the good of the country, it is not widely circulated or used as a guiding document for or by the diaspora.

Review of the External Relations Policy of Saint Lucia sets out a comprehensive review of the external relationships between Saint Lucia, its global trade partners and diaspora by determining strategies to revolutionize the policy direction. This includes recognising the diaspora as integral to home country economic growth, the need to seek partnerships outside the UK, USA and Canada and the idea to compile diaspora skills in a database to identify core skills for development. It further outlines strategic methods for these engagements including looking to the diaspora for connection to new markets and for lobbying on critical matters.

Office for Diaspora Affairs Work Program details 12 strategic priorities under the main objective "to ensure effective engagement of and partnership with the Saint Lucia Diaspora in pursuit of the National Development Agenda". Priorities range from providing training for overseas associations to enhance their service, and promoting Saint Lucia as a seasonal remote-work location, to increasing the participation of the diaspora in national development activities, and enhancing collaboration with other states and international agencies.

#### Trends

Saint Lucia's approach to diaspora engagement is growing strategically as it is putting in place mechanisms to build on successes implementing the diaspora engagement strategy (diaspora policy and homeland guide see below). Diaspora engagement has grown in recognition as a strategic priority for development leading to the creation of a Diaspora Affairs Ministerial Portfolio in the Office of the Prime Minister, headed by an Ambassador, to give special attention to the concerns of Saint Lucians resident in other countries. The External Relations Review Committee focused on the role of diaspora in trade whilst undertaking research on behalf of the Government of Saint Lucia, which laid out a strong argument for utilising diaspora for development.

The Ministry of External Affairs, International Trade, Civil Aviation and Diaspora Affairs, with 10 diplomatic missions and hundreds of foreign service officers located across all continents, has endeavoured to progress on diaspora engagement as a key focus for all overseas departments. In 2021, the ministry expanded to incorporate a Diaspora Affairs Unit, dedicated to ensuring diaspora priorities are kept at the forefront of policy development. The relocation of the Diaspora Affairs Unit from the Office of the Prime Minister to this ministry centred on the belief that it would achieve a better fit by more closely aligning diaspora engagement with Saint Lucia's foreign and economic development policy. In less than a year, this has resulted in the development of the Office for Diaspora Affairs Work Programme (see above).

In 2021, the Prime Minister's party manifesto centred the need to invite highly skilled and distinguished Saint Lucians in the Diaspora back home to share their knowledge, achievements and experiences, as part of an annual event, to inspire and motivate diaspora youth. Additionally, in his 2022 New Year's Day address, the Prime Minister set out the government's intention to change the Constitution to offer citizenship to second generation Saint Lucians. This strategic move would significantly increase the access rights of the grandchildren of diaspora members seeking connections with their heritage, for example, descendants of the Windrush Generation in the UK.

To date, tourism is still the main economic driver for Saint Lucia, thus a significant portion of the country's resources are allocated to its development. In this regard, the Saint Lucia Tourism Authority rebranded their diaspora tourism programme to entice and reward citizens in the diaspora for coming home and contributing to the country's economic development. The new (2022) incentive initiative Lucian Links is another example of the connected nature of the current governmental diaspora strategy. Lucian Links, the Saint Lucia Tourism Authority diaspora tourism programme, was developed as a mean to keep the diaspora connected to their home country. It promotes local businesses and experiences to the diaspora through a discount scheme, with the aim to boost economic growth whilst increasing developing heritage tourism.

# Other key areas the government focuses on for diaspora engagement are:

**Diaspora philanthropy:** Diaspora organisations and individuals made increased contributions to the island in light of the impact of COVID. Concessions on the receipt of **barrels (parcels) from the diaspora** were started earlier than previous years, and this was extended to cover the period of COVID to facilitate members of the diaspora providing assistance to family members at home.

**Economic development**: A key government interest is to target the diaspora as a source of Foreign Direct Investment (FDI). <u>Invest Saint Lucia</u>, the agency responsible for attracting and engaging potential investors, has made it a primary strategic objective to engage Saint Lucians based overseas with the view to attracting them to invest in the homeland.

**Export:** There has been an increased demand from diaspora communities for Saint Lucian domestic products, <u>helping the country increase their exports</u> to outside markets, including a reenergising of the banana market in the UK.

**Skills mapping:** The Saint Lucian Diaspora Affairs Office is exploring methods for data and skills capture with a view to harnessing diaspora capital for development. This is in its infancy but has the potential to provide a steady avenue for skills linked to in-country development.



#### **Achievements**

The diaspora is benefiting from increased connectivity for participation in home country activities virtually. This includes access to national parliamentary debates, festivals and commemorations including emancipation observances and reparation explorations hosted on the social media platforms of the Government of Saint Lucia and those of affiliate bodies. Furthermore, the development of communication channels between the Office for Diaspora Affairs and citizens living overseas is diversifying and strengthening.

#### Obstacles



 Insufficient social protections schemes: Saint Lucians choosing to retire to Saint Lucia after working abroad do not enjoy the same privileges as those who continue to stay in their host country after retirement.

- **Right to vote:** Though dual citizenship has been allowed by the Saint Lucian Government, there is currently no right to vote whilst living overseas. This hampers the diaspora's ability to engage in a civic activity, one which is often considered integral to identity and belonging.
- **Dearth of skills schemes:** There is no state-initiated or led avenue for competency sharing. This remains an avenue on which the Saint Lucian government has not yet formally capitalised.

## Lucian Links 2022

TOURISM

Under Lucian Links, the Saint Lucia Tourism Authority rebranded their diaspora tourism programme to ensure citizens in the diaspora enjoy discounts and rewards for visiting home. This initiative is an example of the connected nature of the current governmental diaspora strategy as it strives to include diaspora engagement in all aspects of the country's development.

# Diaspora Homeland Guide 2018

RETURN / INVESTMENT

It was compiled as a central repository to support efficient process for Returning Saint Lucian nationals. It provides information to assist returnees navigating return, such as entitlements to possessions and information on pertinent organisations and bodies in Saint Lucia. There are also attractive incentives to start a business and for investments.

DATA

With support from a diaspora professional, Mandy Preville-Findlay, co-founder of Beyond Iyanola, EUDiF is equipping relevant departments of the government of Saint Lucia with the skills, knowledge and tools to map the skills of their diaspora. A full report on the skills profile of the Saint Lucian diaspora in the UK has been published.

# Citizenship of Saint Lucia Act

**IDENTITY** 

In 2022, Saint Lucia held a second virtual diaspora engagement meeting to inform overseas nationals about plans to extend citizenship by descent. In 2024, following this outreach, the Parliament approved an amendment to the Citizenship of Saint Lucia Act, granting citizenship to second- and third-generation Saint Lucians born overseas, thereby reinforcing diaspora links and contributions to their country of origin.

# National Migration Policy groundwork

POLICY

In 2024, Saint Lucia and IOM prepared the ground for its first National Migration Policy through stakeholder consultations on migration and diaspora governance, setting a strong base for the launch of the policy development project in January 2025.

# Diaspora related institutions

## At regional level

## Caribbean Community (CARICOM) 1973

CARICOM promotes regional integration through economic and trade union; coordination of the foreign policy and cooperation in areas such as health, education and culture, communications, and industrial relations.

#### **Organisation of Eastern Caribbean States (OECS)** 1981

At regional level OECS was originated from a treaty signed by seven Eastern Caribbean countries "agreeing to cooperate and promote unity and solidarity among the Members."

#### Ministry of External Affairs, International Trade and Civil Aviation 1979

After Saint Lucia gained independence in 1979, the government developed ministries to oversee the running of the country, including external affairs. The names and functions of the ministry in charge of external affairs changed over time. The current Ministry of External Affairs, International Trade, Civil Aviation and Diaspora Affairs oversees all legislation pertaining to the political and economic situations of other countries in relation to that of Saint Lucia, including diaspora engagement for development. It was constituted in 2021 after elections in July of that year. It facilitates the formal and diplomatic engagement of foreign governments with the aim of establishing co-operative and diplomatic relations with friendly countries.

#### Ministry of Home Affairs, Justice and National Security

The Ministry of Home Affairs, Justice and National Security oversees all legislation pertaining to the security and protection of Saint Lucians at home and via immigration services.

At sub-ministerial level

#### Saint Lucia Diaspora Unit 2021

The Saint Lucia Diaspora Unit is located within the Ministry of External Affairs, International Trade and Civil Aviation. It is mandated to provide strategic and tangible oversight on the global Saint Lucian diaspora to determine how the governmental priorities for development are executed with the diaspora at the fore. It was established with the primary goal of "providing special attention to the concerns of Saint Lucians resident in other countries".

The diaspora unit is pursuing the following objectives:

- a. To build partnerships between Saint Lucians living overseas and Saint Lucians at home;
- b. To encourage Saint Lucians living overseas to invest in their country;
- c. To encourage young Saint Lucians living overseas to maintain contact with their country; and
- d. To establish structures to facilitate Saint Lucians overseas in their efforts to reintegrate into the Saint Lucian community.

### Development activities

This charitable organisation was set up to raise funds to help in the development of Anse-La-Raye, a small community to the west of the island of Saint Lucia. Their focus is to connect members from this community based in the UK "culturally and socially; to facilitate in the development and improvement of the local community; and to help increase the profile of Anse-La-Raye in general." It undertakes community fundraising and cultural activities within the UK.
